



ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will continue, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease

Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning;

2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:
 - a. Universal and correct wearing of [masks](#);
 - b. Modifying facilities to allow for [physical distancing](#) (e.g., use of cohorts/podding);
 - c. [Handwashing and respiratory etiquette](#);
 - d. [Cleaning](#) and maintaining healthy facilities, including improving [ventilation](#);
 - e. [Contact tracing](#) in combination with [isolation](#) and [quarantine](#), in collaboration with State and local health departments;
 - f. [Diagnostic](#) and screening testing;
 - g. Efforts to provide COVID-19 [vaccinations to school communities](#);
 - h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
 - i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans

whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

In the best interest of education, the Mount Carmel Area School District recognizes the need to have students participating in face to face instruction as often as possible. This plan outlines the District's strategy to continue to recover from the pandemic. This is a fluid document based on local, state, and federal guidelines, which will continue to develop over time. This plan is based on the District's capability to follow the state, local and federal guidelines to the best of our ability; however, this plan is developed to reduce the level of risk but does not eliminate risks and exposure.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

As Mount Carmel Area School District continues to provide in person instruction staff and students' families will be provided with Pennsylvania Department of Health and CDC Covid-19 virus information for the purpose of self-monitoring. Staff and students will be encouraged to self-monitor for any signs and symptoms of Covid-19 at home prior to attending school. If any signs or COVID-19 symptoms are noted at home, that staff member will be encouraged to seek further medical attention. Staff and students' families will self-monitor at home every day prior to attending school. If a staff member or student develops signs and COVID-19 symptoms while attending school, that staff member or student must report to the nurse immediately for assessment and evaluation. The Mount Carmel Area Nursing professionals and Administrative team will work together, in conjunction with the Pennsylvania Department of Health, to determine the quarantine and/or isolation needs of staff and students.

The Mount Carmel Area School District will implement mandates set forth by the Pennsylvania Department of Health and the Centers for Disease Control and Prevention. The District will

continue to follow the guidelines set forth by the health departments. CDC & PA Department of Health recommendations will be implemented to the extent practicable for mitigation policies in line with the most up-to-date guidance.

Handwashing and respiratory etiquette;</p> | <p>When possible, ensure handwashing strategies include washing with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing. If soap and water are not available and hands are not visibly dirty, use an alcohol-based hand sanitizer that contains at least 60% alcohol</p> |

Cleaning and maintaining healthy facilities, including improving ventilation;</p> | <p>The district will follow the CDC's Guidance for Cleaning & Disinfecting Schools Increase Physical Distancing & Hygiene Practices Scheduled protocol for cleaning high-touch and high-traffic areas including door handles and sink handles.</p> |

Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;</p> | <p>The District will not conduct close contact investigation for possible exposure in the school setting and individuals will not be required to quarantine for potential exposures occurring within our schools.</p> |

| | <p>Household contacts and symptomatic contacts will be emphasized, with non-symptomatic students and staff no longer being required to quarantine, if vaccinated. Household close contacts that are presenting symptoms will quarantine, regardless of vaccination status.</p> <p>Current guidance from the Pennsylvania Department of Health and CDC will be used to help guide the suggested quarantine of students and staff.</p> <p>Positive cases will quarantine as per current CDC guidance.</p> |
| <p>f. <u>Diagnostic</u> and screening testing;</p> | <p>COVID symptom screening should be done by parent/guardian prior to student arrival at school or bus.</p> <p>The District will provide symptom screenings whenever possible.</p> |
| <p>g. Efforts to provide <u>vaccinations to school communities</u>;</p> | <p>Our district will continue to share vaccination information with the school community through the distribution of information in newsletters and letters and on the school district website.</p> |

These precautions include:</p> <p>If a sink is available in the classroom, staff should thoroughly wash hands immediately before and after working with a student. If a sink is not available, use hand sanitizer</p> <p>Avoid the use of communal objects for student reinforcement. If such objects are used with multiple students, each object should be disinfected immediately before and after student use.</p> <p>The district's feeding protocol should be followed when feeding students. Staff should wear gloves when feeding students.</p> |
